AMENDMENT TO AMENDED AND RESTATED CONDOMINIUM DECLARATION FOR CRESCENT RIDGE CONDOMINIUMS

This Amendment to Amended and Restated Condominium Declaration for Crescent Ridge Condominiums is made and executed by the Crescent Ridge Homeowners Association, Inc., a Utah non-profit corporation, of 2244 East 3980 South, Salt Lake City, Utah 84124 (the "Association").

RECITALS

- A. The Amended and Restated Declaration of Condominium for Crescent Ridge Condominiums was recorded on July 30, 1998 as Entry No. 513806 in Book 1169 at Pages 215-265 of the official records of the County Recorder of Summit County, Utah (the "Declaration").
- B. This document affects the real property located in Summit County, Utah, described with particularity on Exhibit "A," attached hereto and incorporated herein by this reference.
- C. The Association desires to maximize the owners' financing options and comply with the requirements of HUD, FHA and other government agencies.
 - D. All of the voting requirements have been satisfied.

AMENDMENT

NOW, THEREFORE, for the reasons recited above, and for the benefit of the Crescent Ridge Condominium Project and the Unit Owners thereof, the Association hereby executes this Amendment to Amended and Restated Condominium Declaration for Crescent Ridge Condominiums.

1. Termination of Rental Pool Requirements. Article IX, Section 9.21 of the Declaration, entitled "Rental of Apartment" is hereby deleted in its entirety. Any and all references to a Rental Pool Agreement or a requirement to participate in a Rental Pool are hereby withdrawn and removed.

- 2. Amendments to Satisfy Requirements of Lenders. The Management Committee is hereby granted the right to amend all or any part of this Declaration to such extent and with such language as may be requested by a State Department of Real Estate, HUD, FHA, VA, Fannie Mae, or Freddie Mac (or similar agencies) and to further amend to the extent requested by any other federal, state or local governmental agency which requests such an amendment as a condition precedent to such agency's approval of this Declaration (such as "certification or re-certification) or approval of the sale of a Lot or Lots, or by any federally chartered lending institution as a condition precedent to lending funds upon the security of the property or any portions thereof. Any such amendment shall be effected by the recordation by the Association of an Amendment duly signed by the President and Secretary, specifying the federal, state or local governmental agency or the federally chartered lending institution requesting the amendment and setting forth the amendatory language requested by such agency or institution. Recordation of such an amendment shall be considered conclusive proof of the agency's or institution's request for such an amendment, and such amendment, when recorded, shall be binding upon all Lots and all persons having an interest therein.
- 3. Unit 110. The structural alterations to Unit 110 - an upper basement closet (4'x13') - has been ratified and approved.
- 4. Unit 114. The structural alternations to Unit 114 - closet in garage (8'x8') - has been ratified and approved.
- 5. **Priority**. In the event of any conflict, incongruity or inconsistency between the provisions of this Amendment and the original Declaration as amended, the former shall in all respects govern and control.
- 6. **Correction on Legal Description**. Exhibit "A" to the Declaration inadvertently omitted Unit 109 and 140-148, inclusive, which were intended to be included. Exhibit "A" attached hereto and incorporated herein by this reference corrects this oversight and scrivener's error.
- 7. Incorporation by Reference. It is expressly agreed by the undersigned that this amendment is supplemental to the Declaration, which is by reference made a part hereof, and all the terms, conditions, and provisions thereof, unless specifically modified herein, are to apply to this contract and are made a part of this contract as though they were expressly rewritten, incorporated, and included herein.
- 8. **Effective Date.** The effective date of this Amendment is the date it is recorded in the office of the County Recorder of Summit County, Utah.
